- The undersigned warrants that he/she is the owner, officer or authorized agent of the purchasing entity (buyer) and has the authority to enter into a legal contract. Purchases subsequent to this application confirm buyer's agreement to these terms and conditions
- Buyer agrees that all payments will be mailed to the remittance address established by the seller. Buyer further agrees that the credit application is accepted on the basis of the applicant complying with our credit terms of sale/payment of net 30 days. Non payment of full amount due by the due date may result in further c.o.d. deliveries and/or withdrawal of credit privilege. No portion of any buyers purchase order shall pre-empt these established terms and conditions of sale/payment.
- Buyer agrees, in the event of delinquency, to pay all costs of Collections, in the event of lawsuit. The non-prevailing party shall pay reasonable attorney fees, collection agency fees, court costs and interest as fixed by the court
- Buyer agrees to be bound by the laws of the state in which the Seller resides
- Buyer authorizes seller to obtain information, as necessary, through trade references, bank references, credit reporting agencies, or other sources in the evaluation of credit worthiness.
- Buyer agrees to notify seller in writing of any pending changes in ownership or change of location or any other changes which may materially effect the terms and conditions of sale or payment to the seller.
- Casual acceptance of late payments does not constitute a change of terms or buyers obligation to adhere to our terms of sale
- All dispute, whether involving pricing, quality etc. will be considered only if brought to our attention within 7 calendar days from date of delivery/invoice.
